1 Respective responsibilities of the body and the auditor

2 External auditor report 2018/19

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Section 1, Assertion 3 has been incorrectly completed as in the completion of the Annual Internal Audit Report, the internal auditor has drawn attention to significant weaknesses in relation to PAYE and NI requirements not being properly applied. We note that the smaller authority has resolved this issue since then.
