PARISHIONERS' DISCUSSION

PC Wheeler reported that there had been five crimes and 35 reported incidents. Three people were in custody from the Wheal Jewel site. Crime numbers were falling.

There had been a number of matters raised with Councillors regarding skateboarding. These seem to have emanated from an incident in Frogpool where a motorist narrowly missed a child skateboarding in the road incurring the wrath of the parent. The Clerk had had it reported that there was a rumour that the Council were building a skateboard park at the end of the road in question - Treneglos. The Councillors agreed the best place for such a park would be the Richard Jory Playing Field but nothing would be done unless a need was proved.
