PARISHIONERS' DISCUSSION

PC Bob Mears introduced himself as the new Beat manager replacing PC Wheeler as Community Policeman the purpose being to show a new police presence 'on the streets' instead of in vehicles although in the case of this Parish most involvement would be via vehicle. He reported that since 1st April there had been reported a common assault at Poldice, burglaries at Comford and Pengreep, criminal damage at Pengreep and Pulla Cross and damage to a caravan at Wheal Jewell. (N.B. Numbers would show an increase as all reports are now recorded whether or not a complaint is laid.) One family has moved on from Wheal Jewell and there seems to be a lowering of associated reports in this area.

Paul Millett had reported that the new No Horses signs had been installed at the disputed footpath and it was agreed to adopt a 'wait and see' policy pending addition of more signs by this Council. He also reported the presence of Japanese Knotweed near Crowsmenegas and the Clerk was to report to CCC.

The Clerk reported that Norma Johns who had stood uncontested at the last election had informed him that she worked nights and was unable to attend meetings in the evening and it was mutually agreed that she should stand down. The fact that she had not signed the Declaration or the Disclosure of Interests would also disqualify her. The gentleman of the Press present was asked to include an article in the West Briton advising of two vacancies and asking parties interested to contact the Clerk. The Clerk was also to advertise.

Prayers were said and the April 2003 Minutes and those of the Annual Meeting held on 7th May 2003 were signed as correct.
