Paul Millett reported that he had cleared a fallen tree by the Cemetery, that the Hicks Mill footpath was muddy following the County Council's failure to address the erosion and it also needed trimming and that he would obtain quotes for the felling of the sycamore in Gwennap Churchyard.

There was a discussion on the proposed sale of the field adjacent to Cusgarne School. Cllr Whiteley stated that its possible redevelopment for community facilities was allowed under Policy 12F. One Parishioner suggested that Compulsory powers should be used. The Chairman explained that the Parish Council had no such power.

Other wished to object to the proposed bridleway at Wheal Jewell on the grounds that if opened up it would afford another getaway route for miscreants from the caravan park He produced copies of letters of objection from the police Cornwall Wildlife trust and health & safety at County Social Services.and
