## MINUTES OF MEETING HELD AT GWENNAP CHURCH HALL ON 25<sup>th</sup> November 2004

### PARISHIONERS' DISCUSSION

PC Jones reported that there had been four reported crimes – transformer stolen from field in Little Beside, vehicle stereo stolen in Cusgarne, warehouse broken into at United Downs and number plate taken in Cusgarne. As this is 1.8% of all reported crimes in the Falmouth and Penryn Sub-division Gwennap is the safest place to reside in that Division. Young motorcyclist given ASB warning at Wheal Maid and his parents spoken to. Might act as a deterrent – we hope!

Mr Trenah sat in as an observer having comparatively recently moved to the Parish and wanted to get to know what happened. Messrs Wharton and Barry asked about the Travellers and were advised by Cllrs Hichens and Whiteley that the relevant notices had been served (which covered new arrivals as well) and they should go in December. Some concerned that Phil Eaton the County Council's Travellers Liaison Officer was working to a different agenda than the rest of the authorities.

### Prayers were said.

Cllr Lanyon objected to the Minutes of the October 2004 Meeting produced by the Clerk stating that it had been resolved by the Council at that Meeting to write to Cath Statham to duplicate Mineral Tramways Funding Applications in respect of Wheal Maid. The Clerk produced his notes of the Meeting which did not confirm this. The other Councillors had no recollection the Minutes as drawn were signed as correct.

The Clerk had written in the agreed form to every household in the Parish calling for volunteers and gave a précis of the responses. Messrs. Wharton and Barry asked to be listed and the Clerk explained that he was waiting for a short while before writing to all applicants with full details and setting up a selection procedure.

1. For the avoidance of doubt and confusion IT WAS RESOLVED that the primary object of the Wheal Maid Steering Group shall be to obtain grant funding for the restoration of the valley to the extent that the Council might obtain Public Liability Insurance therefor for the use thereof by the public as a public open space and that the secondary object of the Group shall be to obtain funding for the regeneration of the valley and/or the provision of other recreational facilities thereon for the benefit of the public using Wheal Maid
2. IT WAS RESOLVED to purchase from Contract Sign Systems No6 1200mm x 1200mm 3mm dibond warning signs in the form drafted by the Clerk at £186 each and to affix the same to the existing sign supports. (Cllr Lanyon offered the use of his generator for drilling purposes)
3. IT WAS RESOLVED that Cllr Lanyon should obtain quotes for the replacement of the shaft covering at the middle dam
4. IT was resolved to hire a JCB for the purpose of 3 above, the relocation of the bollard at the Cusvey end of the valley to prevent 4WD access and to transfer the tramway setts from storage at the property of Chris Massie to the property of Cllr Snell
