## MINUTES OF MEETING HELD AT GWENNAP CHURCH HALL ON 29<sup>th</sup> June 2006

### PARISHIONERS' DISCUSSION

1. Trimming was required on footpath 25 at Higher Trehaddle. It was noted that several paths were now growing in fast, and may need two cuts during the year.
2. The Clerk was asked to chase Carrick for a reply on the occupation of land at Trehaddle, off Pulla Hill.
3. The island outside the cemetery was overgrown by weeds. The Clerk explained that our trimmer had it in hand, but it was decided that after it had been cleared, the Clerk should get some other ground cover plants as those currently planted were growing upwards, not across the ground.
4. Mr Layte was given an update of matters arising from the previous months' Wheal Maid discussions. It seemed that Carrick environmental department had sent their officers to the site on motorbikes. This was news to the Councillors.
5. Mr Layte also spoke of the problem in getting action from County to clear Japanese Knotweed from alongside the lane at Higher Goongumpas. The Clerk and Cllr. Hichens would separately contact James Macfarlane to try to resolve the matter.

### MATTERS ARISING

06/62

1. The County Council had agreed to place temporary SpeedVISOR equipment on the road from St Day to Crofthandy in an attempt to get motorists to adhere to the speed limit. Councillors were happy with the proposed siting.
2. County Cllr. Hichens confirmed that the footway problem at Frogpool would now be carried out using his 'allowance', although he couldn't be sure when the works would be carried out.
3. The Clerk would contact Dave Clarke at Countryside Access to point out that access had been gained via the County's gate on the Mount Wellington Road and the burning of cable had taken place. County needed to ensure their gate was secure.

## **SCHOOL GOVERNORS REPORT.**

**06/63**

Cllr. Lanyon gave a report on Cusgarne School. There were currently 69 pupils and the recent Ofsted visit gave the school very high marks. Cllr. Lanyon had recently attended a course on School Travel Plans which were relevant to us in a rural setting. Parking at the school continued to be a problem although there were ongoing discussions with adjacent landowners.

Cllr. Hichens would chase a reply from the County Education department regarding the area of potential storage space beneath the school.

## **CORRESPONDENCE**

1. CCC Mineral Tramways - survey volunteers were required for a Mineral Tramways project.
2. Frogpool Cusgarne Football Club - permission was agreed for their annual 5 a side tournament in July.
3. CAPTC - Police mergers - noted.
4. Devon & Cornwall Constabulary - a report from Community Constable Osborne explained that her Inspector felt that her attendance at Council meetings in the summer months was not best use of her time, so reports would be sent for the next few months.  
There had only been one reported crime in the past two months, a vehicle theft at United. Meetings continued to be held to resolve the off-road biking problem, but she did have an access problem at Wheal Maid with fallen stones blocking the Cornish Way – the clerk would ask Paul Chegwiddden to clear the path.

6. National Childbirth Trust - application for a grant not agreed.
7. Carharrack Parish Council minutes, May 2006 - noted.
8. CRCC - leaflets “Where to get help in Cornwall” will be placed on the Council’s notice boards.

10. K Furnish - Hale Mills. It was agreed to write back to Mr Furnish confirming that we had no immediate plans for a barrier at the Hale Mills end of Wheal Maid, and before we did erect anything we would consult him.

12. ODPM - Local Authority Byelaws discussion paper - noted.
13. CDC - Performance Plan 2006 – 2007 - noted.
14. CCC - Hick’s Mill Bridge strengthening. Clerk to reply confirming our agreement but asking for a sympathetic approach to maintain the character.
15. Environmental Agency - desk study report. It was noted that the report was getting closer, but disappointment was expressed at the speed it was taking. The Clerk will chase the Environment Agency each month so that the Council can be appraised of the situation.
