### **MINUTES OF MEETING** HELD AT THE PARISH ROOMS, PULLA CROSS ON 16<sup>th</sup> AUGUST 2012

### **PUBLIC CLINIC**

- 1. Crofthandy residents organising the Chapel Lane surface repairs attended. They explained that they had raised £11,500 from residents but were short of £500 because of additional drainage works, could the Parish Council contribute towards this? The Chairman explained that the matter would be discussed later in the agenda. Cllr Lanyon left the room whilst the matter was being discussed as he had declared an interest.
- Mr & Mrs Medlyn told the Council that they had secured a delivery of 40 tons of road planings to improve the surface of Higher Goongumpas Lane, but the first load could not get up the lane because of the overgrown vegetation. The whole offer was lost. The Clerk would give the Medlyns forms that they should complete to send to Cornwall Council, who will visit the lane and if necessary, approach the landowners to cut back the hedges.

### **CORRESPONDENCE**

### 12/059

- 1. The litter picking report for August was noted.
- A letter from Cornwall Council planning enforcement accepted that there had been a breach of planning control at the Goongumpas Quarry, but that because there is insufficient harm caused, no further action would be taken. Because the 'development' is a breach of planning control, the landowner would be required to submit a retrospective planning application. Cllr Lanyon mentioned that the new surface is gravel, and because of the slope, some were afraid of slipping. The Clerk will raise this with the Countryside Ranger.
- The Mining Villages Regeneration Group's minutes of their meeting held on 2<sup>nd</sup> August were noted.
- Correspondence from Ryan Law confirmed that the Geothermal project was at a standstill through reduced subsidy levels from government which were putting off prospective business partners.
- The Localism July newsletter from Cornwall Council had been circulated to all Councillors.
- The Wheal Maid monthly inspection report was noted.
- Cornwall Council had sent details of their consultation on charging for traffic management at events.
- The Notes of Taylor's Consolidation Works meeting held on 24th July at the offices of pdpGreen were received. Initial preparatory works were now being set in motion before advertising for a main contractor. The Notes of a meeting of the Mining Villages Network held on 2<sup>nd</sup> August were noted.

### WHEAL MAID

### 12/063

- 1. The Clerk was still trying to enlist a new Competent Person. There were a couple of possibilities.
- 2. The Chairman was not present therefore an update on the proposed Mountain Bike events would be placed on the next agenda.
- 3. The three large interpretation Boards had been erected in the valley, and two smaller ones detailing the history behind the Tailings Lagoons would be in place by the end of the month.

### **REPAIRS & MAINTENANCE**

#### 12/064

- 1. Because of the works at Taylor's, the access entrance opposite the Industrial Estate has had to have a chain and padlock fitted, and the large boulders moved aside.
- 2. The mirror requested for the toilet in the Rooms had been purchased and fitted by the Clerk and Cllr Humble.
- 3. Cllr Humble had also fitted a new water heater in the same toilet the previous one was leaking.
- 4. The Floodlights had been replaced where needed, and the lighting in the external ladies toilet now worked. The Clerk reported that the local electrician had given a generous discount as a contribution to the community.
- 5. The same electrician had fitted a replacement Hand Dryer in the ladies toilet at no charge. The Council noted their appreciation for his contribution and the Clerk was asked to write expressing this.
  The Clerk asked for retrospective approval for the purchase of the replacement hand drier. It was RESOLVED to approve it.

After much discussion, it was RESOLVED by all Councillors to grant the Crofthandy residents the sum of £500 from reserves towards the water drainage works in Chapel Lane.
