PARISHIONERS' DISCUSSION

Alan Miller of CDC gave a short talk on the CDC proposal to introduce a District wide kerbside collection of recyclables. A plastic bag would be provided for paper and a plastic box for plastic tins and glass. Sorting would be by the vehicle operative. Collection would be bi-weekly alternating with the collection of garden waste. The Council expressed concern that the receptacles were too small considering the bi-weekly collection and were of the view that sorting should be at the depot.

PC Bob Mears was not present.

Mr. Bray said he was a close neighbour in respect of the planning application at the Old Quarry Hicks Mill and was seriously inconvenienced by the noise from log cutting. The Chairman said his views would be taken into account when the Council discussed the application.

Poppy Nicolls complained about the lack of visibility to horse riders exiting the bridleway at the rear of the playing field into the Pulla Cross/Frogpool Road and wondered if a mirror could be installed. Cllr. Hichens said that this was not a matter for Highways and the Chairman said that if she wanted to put one up with the cooperation of the landowner the Council would be unlikely to object.

Paul Millett reported the felling of the tree in Gwennap Churchyard and that the PCC were very happy with it. He also reported that 15 alder buckhorn had been planted. He raised again the question of the signage at Trehaddle and Cllr Hichens said he would take this up.

Prayers were said and the Minutes of the December 2003 Meeting were signed as correct.

The Chairman reported that Nigel Webb had some heaters for possible use in the Rova Cabin which he would install. The Council would pay for the wiring etc but could replace the heaters if not satisfactory.
