





The Minutes of the regular Meeting of the Parish Council

held on Tuesday 13th December 2024, 7pm

Members of the Public were in attendance.

- **1.1** Apologies for absence were received and accepted from Cllr Veryan Pascoe-Edward and Cornwall Councillor John Thomas MBE.
- 2. No declarations of interest were received.
- 3. Public Session:
- 3.1 Georgina Hayman from Coastline Housing presented updates on the designs for the Trelyn Affordable Housing development at Frogpool, following public consultation. Questions from the public and Councillors were addressed. Most concerns expressed by residents have been addressed. The updated designs are available on the Parish Council website.
- 3.2 Tim Dunstone, representing the Bissoe Community Speed Watch Group, read out a written statement about traffic speed through the village. He requested the Parish Council's support in opposing a proposed speed limit increase from 30 mph to 40 mph. The Council RESOLVED to support the group and to write to Cornwall Council.
- 3.3 The Applicant re PA24/08559 answered questions regarding their planning application.
- 3.4 A member of the public discussed a tree plantation in Frogpool owned by their family. They outlined their intention to apply for a licence to remove trees posing hazards to powerlines.
- **4.** Cornwall Councillor John Thomas MBE had sent his apologies that he could not attend the meeting. He did not send a report.
- **5.** It was PROPOSED by RW, SECONDED by AF and RESOLVED that the minutes of the Parish Council meeting of 13th November 2024 be approved as a correct record. The Chair signed the approved minutes of that meeting.
- **6.** The Council received correspondence Email from Bissoe Traffic group. Discussed in item 3.2
- 7. Affordable Housing: See item 3.1
- **8.** The Clerk reported: The Application to the National Lottery Awards for All had been unsuccessful. The Accessibility survey for the Richard Jory playing field will take place on Tuesday 17th December.

To discuss the consultation for Bissoe Highway Improvements, see item 3.2. It was PROPOSED by RW, SECONDED by GF and RESOLVED to support the Bissoe Community Speed Watch Group in objecting to the proposed increase in the speed limit through the village.

To discuss the consultation for Gwennap Parish Gateways. It was PROPOSED by RW, SECONDED by ST and RESOLVED to agree to the proposals. These will be shown on the Parish website.

Location: Geothermal Engineering Unit 2 United Downs Industrial Park St Day Redruth Cornwall TR16 5HY Proposal yep Proposed siting of a Lithium Demonstration Plant for the purposes of testing and producing lithium recovered from geothermal brine in quantities up to 100 tonnes per annum on land adjacent to the United Downs Geothermal Power Plant.
